Internal Quality Assurance Cell Meeting

A meeting of the IQAC was held in the Conference Hall (Humanities Building) on 25.01,2024 at 11.00 am.

Minutes of the Meeting:

The meeting began with an address by **Rev. Fr. Principal, Dr. Nabor Lakra, S.J.** Fr. Nabor began with a reference to Atomic Habit – A small change can bring about a big change. He also spoke about the importance of punctuality and finishing the work assigned, on time.

Agenda 1: Approval of Conferment of Autonomous Status

Rev. Fr. Nabor Lakra informed the house that the Autonomous Status for St. Xavier's College, Ranchi has been extended till May 2027. Fr. Nabor read out the letter dated 13th November 2023 issued by the University Grants Commission, New Delhi regarding the extension of Autonomous Status to St. Xavier's College, Ranchi. The letter stated that, the Commission at its meeting held on 03.11.2023 has approved the recommendation of the Standing Committee on Autonomous Colleges to extend the autonomous status to St. Xavier's College, Dr. Camil Bulke Path, Ranchi-834001 affiliated to Ranchi University, Ranchi for a period of 05 years from the academic year 2022-2023 to 2026-2027 as per clause 8.1 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023. Fr. Nabor also mentioned that upon conferment of Autonomous Status the College has been advised the following three requirements:

- i) The College is advised to go for the required NAAC/NBA accreditation at least six months before the expiry of current validity and obtain the grading NAAC/NBA as per the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023 and intimate the same to UGC to revisit the above decision, if required.
- ii) The College/Institute is advised to submit a report regarding Examination Cell and constitution of Statutory Bodies as required under Clauses 11 and 12 of the UGC (Conferment of Autonomous Status Upon Colleges and

Noncompliance of the above shall attract action as per Clause – 13 of the UGC Regulations -2023.

 The College/Institute is advised to take necessary steps for implementation of NEP 2020 and intimate the UGC.

Resolution: IQAC unanimously approved the Conferment of Autonomous Status to St. Xavier's College, Ranchi.

Agenda 2: Constitution of Statutory Bodies as per UGC Guidelines

On the above matter **Dr. Sanjay Kumar** enquired whether the constitution of the IQAC body has been done as per the guideline/regulations of UGC. Dr. Sanjay Kumar also suggested that the formalities from our side regarding the Governing Body, the Academic Council and the Board of Studies be completed as soon as possible. Prof. B.K. Sinha pointed out that the Statutory Bodies should be constituted as per UGC guidelines.

With regard to the Examination Committee, Prof. B.K. Sinha suggested to have one representative from the affiliating university i.e. Ranchi University, Ranchi into our Examination committee. This will help us in resolving many issues regarding examinations. The Formation of an Examination Committee has been proposed and a few members from different departments have already been suggested by Prof. B.K. Sinha.

The Examination Committee of St. Xavier's College (Autonomous), Ranchi is a statutory body constituted in accordance with the UGC guidelines for Autonomous Colleges. The Committee is headed by the Controller of Examinations (CoE) and the Principal acts as the Chief Controller of Examinations.

Dr. Shiv Kumar, IQAC Coordinator, informed the house that the last date for submission of **AQAR 2022-2023** has been extended to 29th February 2024. Dr. Shiv Kumar discussed all the **Seven Criteria** of NAAC at length, point by point. The members present suggested the following points:

- a) The landline number needs to be replaced with a working mobile no.
- b) Alternate email id should not be left blank and if required a new email ID be created.
- c) Registration for Academic Bank of Credit (ABC) is a must. Academic Bank of Credit (ABC) is a virtual/digital storehouse that contains the information of the credits earned by individual students throughout their learning journey. It will enable students to open their accounts and give multiple options for entering and leaving colleges or universities.
- d) All the activities of the College including financial matters be routed through the IQAC.
- e) "No Files Uploaded" in NAAC portal be looked into and wherever possible some form of report or information regarding that point to be uploaded.
- f) It was suggested by most members present that the recorded lectures can be uploaded and the link can be shared at the NAAC Portal (wherever applicable).
- g) A robust mechanism to have a Stock-Register is a must as envisaged by the members present.

Resolution: The IQAC with Voice Vote approved the AQAR 2022-23 for submission to NAAC.
